Routes to Clean Air 2025

The IAQM's annual conference, Routes to Clean Air, returns on Monday 20th – Tuesday 21st October at Woburn House, London. The event is the largest gathering of IAQM members each year and gives air quality practitioners and professionals a platform to share knowledge and explore topical subjects in air quality management. Spaces are filling up fast, so book your ticket soon!

The session themes across the two days include: health impacts; indoor air quality; inequalities; novel pollutants; advocacy; innovation and national insights. The <u>agenda</u> can be found on the event page.

IAQM ECN Vice Chair Mark Nichols will be chairing the session on novel pollutants on day one, where we will be hearing from two members of the ECN:

- Owen Dudman (Assistant Consultant, AQC) who will be providing a talk on ultrafine particles.
- Dr Rachel Whitty (Air Quality Consultant, WSP) who will be providing a talk on nitrosamine assessment methodology and implications for permitting. Rachel has shared her thoughts on presenting at Routes to Clean Air: "I am excited to present recent work on modelling amine emissions from carbon capture facilities, as part of the Early Career Network session at Routes to Clean Air. It's a great opportunity to contribute to the conversation around permitting and environmental impact assessments."

Day 2 will also include a pre-conference ECN discussion hosted by Mark Nichols and is open to all ECN members.



The Air Necessities: tools and techniques for air quality monitoring

Our latest in-person ECN event: 'The Air Necessities: tools and techniques for air quality monitoring' was held on 2nd July in London with a successful turnout of around 30 attendees.

Attendees heard from speakers from the London Borough of Camden; UK Centre for Ecology & Hydrology; Bureau Veritas Group; RSSB and AtkinsRéalis, covering a range of tools, techniques and case studies, and had the chance to find out more in engaging Q&As after each presentation and a well-attended networking session in the evening, which facilitated some interesting further discussions between attendees and speakers.

Industry updates & resources

Low-Cost Sensors

The IAQM have also published a Position Statement outlining their position on the use of low-cost sensor systems for PM10, in the vicinity of demolition and construction sites.

It is designed to sit alongside the use of the <u>IAQM guidance on Air Quality Monitoring in the Vicinity of Demolition and Construction Sites (2018)</u>.

The Position Statement sets out the IAQM's views on the use of low-cost sensor systems for monitoring PM10 around construction sites and provides recommendations for their use. It also sets out the challenges around their use and relevant standards and limitations.

Welsh Government – Promoting Awareness of Air Pollution Delivery Plan progress update

<u>The Welsh Government is preparing a delivery plan</u> to promote the awareness of air quality in Wales and how the government is meeting its objectives in its national air quality strategy, <u>Clean Air Plan for Wales: Healthy Air, Healthy Wales</u>. The public consultation phase is open for comments until 28th October 2025.

Defra – Consultation on modernising environmental permitting for industry

Defra has opened up consultation on improving environmental permitting for industry across multiple emissions sources which includes, but not limited to, small/medium combustion plant; back-up generators and data centres. It also includes a chapter on interactions with legislative requirements such as local planning, Local Air Quality Management and emission limit value guidance. The public consultation phase is open for comments until 21st October 2025.

Alari et al (2025) – Quantifying the short-term mortality effects of wildfire smoke in Europe

A study funded by the European Commission found that global deaths attributed to respiratory and cardiovascular diseases caused by PM_{2.5} pollution from forest fires is underestimated by 93%. These findings are especially prevalent given the extent of wildfires across Southern Europe over summer this year.

Healthy Air Coalition - "Making Britain's air cleaner, healthier and better to breathe: A blueprint for government action on clean air."

The Healthy Air Coalition comprises of over 30 health, environmental, and transport organisations, which calls for a new Clean Air Act that treats clean air as a fundamental right in the UK. The report contains key recommendations including, but not limited to:

- Aligning UK air quality objectives with WHO interim target guideline values (PM $_{2.5}$ annual mean limit value of 10 μ g/m 3 and NO $_2$ annual mean limit value of 20 μ g/m 3 by 2030)
- Setting sector specific actions targeting emissions from transport; domestic; heating; industry and agriculture;
- Implement legal mandates on regular progress review of attainment of air quality targets every four years;
- Committing to long-term funding for local authorities to enforce regulations and investment into air pollutant mitigation measures.

University of Chicago - Air Quality Life Index 2025 Report

The <u>annual update to the Air Quality Life Index</u> highlights the continuation of the air quality issue: $PM_{2.5}$ continues to be the greatest external health threat globally in reducing life expectancy (1.9 years). The paper provides time-series graphs of average $PM_{2.5}$ concentrations across major regions across the world to demonstrate that $PM_{2.5}$ continues to be an issue in many non-European regions. It provides a summary on air quality monitoring density for the majority of countries across the world.

Department for Transport – HS2 Air Quality Annual Report 2024

The <u>annual status report for the air quality impacts on the construction of the HS2 Phase</u>
<u>One route</u> includes:

- A summary of significant effects identified in the Environmental Statement;
- The status of compliance with NO₂ and PM air quality objectives from monitoring undertaken by HS2;
- The proposed measures to improve air quality and offset the impact of HS2, which include establishing construction vehicle emission standards and dust mitigation measures.

All across the world, people came together to use alternative sustainable transport to cars. This was facilitated by local and regional authorities in activities such as:


- Pedestrianisation of major streets in capital cities such as Oxford Street in London.


