[6] Membership sub-committee (TR)

Membership numbers as of 22nd March stood at 650. This represents a 2.5% growth on January numbers. [7] Short Course Endorsement sub-committee (RF)

Introducing a charging system for short course endorsement

Three courses are currently endorsed by the IAQM:

Essentials of AQM: An Introduction to Air Quality Management - EMAQ+

Odour Study Day Course - Silsoe Odours

Air Quality – 5 x one-day courses – University of the West of England

Courses are endorsed for a period of three years, subject to annual progress reports. After three years they are invited for re-endorsement. The Short Course Endorsement Subcommittee assesses applications for endorsement using a set of assessment criteria.

Benefits of endorsement

Provides a clear signal that the IAQM supports the aims and objectives of the course

Signals to attendees that the course operates and maintains high standards in its content and delivery External endorsement ensures critical self-assessment and continuous quality assurance

Equips AQPs with sound knowledge and skills in subjects relevant to the science and practice of Air Quality Management

Course listed on the IAQM website and promoted through IAQM social media channels

Expanding the scheme

A number of courses have been identified that could be eligible for endorsement:

Air pollution on this list under transport - Newcastle University

Introduction to air pollution modelling - Wessex Institute

Industrial air pollution monitoring - Leeds University

Process emissions and control - Cranfield University

Expanding the scheme would provide an opportunity for increasing the role of the IAQM in providing quality assurance of courses in the sector as well as promote the IAQM among new audiences.

Introducing fees for endorsement

To diversify income streams for the IAQM, a charging system could be established. Research was done to find comparable schemes in place that could inform the pricing structure for endorsement. Charging a fee also signals the quality of IAQM endorsement and reflects the value of IAQM promoting the courses on its website.

There is a dearth of information available about the fees for endorsing courses, but the following fees were identified which may provide some steer:

Key questions to consider:

• Do we want to invite courses to apply?

If yes,

- What should we charge for endorsement?
- Should this fee cover the full three years and should we charge a renewal fee at the end of the three years?

Recommendation

The project office recommends that the IAQM introduce a fee for Short Course Endorsement on a graded scale depending on the length of the course. The cost of an application for endorsement award depends on the length of the programme and the volume of materials to review which would typically fall within the range £100-500. We believe that this reflects the value of IAQM endorsement, whilst also not being prohibitive for course providers.

Charging for endorsements reflects the significant staff and subcommittee time that goes into assessing short courses and signals the prestige of IAQM endorsement.

[9] Climate Change Working Group (CR)

Two meetings have been held with the working group and EC met with EPUK to discuss their work and potential cross over in the update of their guidance on climate change and air quality for local authorities. At the first meeting it was discussed that being a proactive consultee in the area of climate change and air quality would be a good focus for the working group.

The working group are progressing with a news story letting members know about them and an initial thought piece on what net zero means for air quality professionals, however we will look to publish this after the Committee meeting on the 6th April. Before the meeting the group want to draft a short mission statement for the group which provides an aim for the group that is achievable and can focus our activities.

Other ideas raised for the group to look into includes thinking about producing a tool to support organisations reporting on GHG and air quality. Also there is potential for further Thought peices e.g. whether current guidance supports us to reaching net zero.

Construction Dust Risk Assessment guidance (provided by Matt Stoaling)

Comments have now been received on my internal pre-draft so MS will pull these together and get a draft out - aiming by end April as long as work allows.

- **b. Modelling guidance (KL) –** verbal update
- c. Guidance on Land-Use Planning and Development Control (KL) verbal update
- d. Westminster Commission on Road Air Quality (CAM)

The initial stage draft has been compiled, but progress halted as CIBSE was awaiting an air quality round table event with RIBA. CR invited to air quality round table event with RIBA to discuss how RIBA consider air quality more through the design stages. This was a welcomed invite as aligned with the AQ across RIBA stages document. CR and CIBSE Chair followed this up to arrange initial call with RIBA and from this call a workshop with key architects is to be arranged to discuss their thoughts/potential input and what they would see as being required from this. Following this meeting the draft can be progressed – and require IAQM review / input – with potential for more active involvement as part of a combined IAQM/CIBSE/RIBA workshop.

g. Collaboration with IES Land Condition Community (SH)

SH and CR joined the IES Land Condition Community Working Group meeting on the 17th February. SH put forward a proposal for developing joint guidance linking air quality and contaminated land discuplines and what the objective would be. At the meeting attendees discussed various routes to producing it, including potential collaborations, such as with CIRIA.

Next steps are to 1) understand the extent of progress undertaken by local authorities, 2) ask other consultants to openly share thoughts, ideas and opinions, and 3) establish small working group to define the problem.

Introduction and process

The IAQM conducts a CPD audit every three years of its professional membership. 5% of members are audited. Each person needs to be audited by two people and the IAQM Committee will be responsible for auditing – with current membership numbers each Committee member should only need to audit ~2 record each. CPD auditing is important to ensure that members are staying up to date with CPD requirements and to maintain professionalism among members.

Members are randomly chosen for auditing and each member will be allocated to an auditor, following the requirements of the relevant licensing body:

- CEnv & CSci must be audited by at least one CSci and one other chartered assessor (CEnv and/or CSci)
- REnvP must be audited by at least one CEnv or REnvP
- REnvTech must be audited by at least one CEnv, REnvP or REnvTech

Auditors will need to complete a short training video/document and exercise by the end of May. This exercise will involve a practice audit of 3 randomly selected past CPD records of varying quality across the categories (breadth, hours, reflections, suitability).

Those who did not pass the audit, but have been responsive to communication, should be re-audited the following year, as opposed to resubmitting their record to pass within the current year's audit.

Timeline

- Mid April Send through a reminder email to those who have not completed the required CPD that auditing will be taking place and that they need to update record by mid-May
- May Auditors receive training on how to carry out audit
- June Audit takes place
- July Feedback provided to members based on auditors comments
