Forums

On the 15th September an IAQM forum was held featuring presentations by Claire Holman, Carl Hawkings and Tim Williamson, and a lightning presentation by Michael Bull. The forum was on the topic: WHO guidelines for the UK: Should the UK adopt them and how should we implement them? This event was attended by 127 people.

Routes to Clean Air

At this year's RTCA conference we had 51 delegates in attendance and 9 speakers. We had 5 sponsors, 2 x gold, 1 x silver and 2 x bronze as well as 1 exhibitor. The feedback from the delegate survey has been very positive with 96% saying the conference mostly or completely met their expectations. 70% thought that the speakers were engaging and over 90% said the presentations were interesting and informative. There were a few comments in the suggested improvements section of the survey asking for more networking time and making the conference a bit longer.

AGM

This year's AGM is being held on the 28th November. The event will feature the Chair's report for the year, a speech by Bernard Fisher to mark the 20th Anniversary of the IAQM, and a keynote speech by Helen ApSimon on An integrated approach to improving air quality.

The MAQ conference has been confirmed for the 28th March at Coin Street Conference Centre in London. The dates are on hold with the venue and the contract is being issued next week. RB and SH are working together on the agenda.

TECHNICAL

Construction Dust Risk Assessment guidance (provided by Matt Stoaling)

Matt Stoaling will have the amended draft by the end of the year.

b. Modelling guidance (KL)

No update.

c. Guidance on Land-Use Planning and Development Control (CAM)

CAM circulated a draft for comments by 4 November. No comments were received so appendix document in draft should be passed on to the IES Publications Lead to be published alongside IAQM guidance.

- d. Westminster Commission on Road Air Quality (CAM) verbal update
- e. Traffic and Transport Working Group (SP)

No update.

f. Air quality across the design process – CIBSE (CR)

The CIBSE AQ working group are currently engaging with RIBA to get architect contacts and are awaiting response. They are looking to arrange a sprint event with architects and mechanical engineers to gain their insights.

g. Collaboration with IES Land Condition Community (SH/EC)

SH prepared a proposal for a potential collaboration between IAQM and the IES Land Condition Community to support air quality and land contamination specialists, developers and local authorities by producing guidance that sets out best practice for assessing, modelling, monitoring and managing emissions to air (VOCs, odours) from the remediation stage of land developments, and communication of risk in light of increasing public awareness of air emissions on health.

This was discussed by the Land Condition Community in September. It was agreed that there is a gap here and that guidance would be useful.

It was noted that there is a SoBRA Vapour subgroup which could be approached for their views. Some of the projects facing this issue have been associated with National Grid, but they may still be useful to approach to see how they communicate risk around gasworks projects. It was noted that there is some HSE guidance that gives odour thresholds for workers in factory settings which have been used as a basis for discussion at National Grid sites.

It was also noted that it would be useful to reach out to Nicola Harries at CL:AIRE to see if some guidance on health risk and odours could be produced, with the potential for getting sponsorship.

Claire Holman also raised that this was an area of interest and proposed that it would be good if IAQM lead it, and as a starting point we should ask a number of consultants to send use their reports (assuming they are in the public domain) to see if a common approach is emerging.

h. EPUK guidance on Air Quality and Climate Change Guidance for Local Authorities

As discussed in a recent email EPUK have asked whether the IAQM would be keen to feed into their update of their local authority climate change guidance. In particular they are keen to get input from air quality professionals about the measures listed and case studies etc.

A few members expressed an interest so it would be useful to work out next steps for providing input.

STRATEGY

[13] Proposed strategy meeting (CAM)

With the change of Chair it seems like a good time to get the old and new committee (and Honorary Fellows) together to reflect on what IAQM is for, where are we going and how will we get there. CAM proposes we hold the meeting between now and the end of 2022 so any committee members who are standing down will be most likely to be involved, but if a date can't be found for December we can look at early January.

[15] IAQM Competency-based membership (BF)

An IAQM subgroup has been considering a new competency-based approach to membership grades of the organisation. After discussion it is proposed that the IAQM retain its four membership grades: affiliate, associate, member and fellow. Entry to the lowest membership grade "associate" should remain as at present with the aim to encourage as many as possible to enter the profession.

A competency-based approach should be focused on the key grade of "membership". Guidance will be provided as to how applicants for membership can reflect on the skills in eight areas of air quality management, such as (1) policy, regulation and legislation, (2) guidance and tools, (3) technical know

how, etc. Applicants would provide evidence of these in addition to recording their experience. The intention is not to make the application process more complicated, but to encourage a process of learning and personal development which would run in parallel with the usual reporting of experience in a curriculum vitae, or an annual workplace review. The intention is that applicants will be encouraged to continue to develop their skills in the broad areas outlined in the guide as members of the IAQM.

The IAQM committee, and in particular the Membership Subcommittee, are asked to endorse this approach. The next step would be to publish the guide and for the Membership Committee to agree an evaluation procedure, which could be a "points based" system discussed in the meeting.
