- 2. Communications & Discussions Organiser: assist with communications to members of the Early Careers Network (e.g. event details, news, website, LinkedIn, discussion board).



## Workshop series on public speaking

## Construction Dust Guidance Update

In August 2023, the IAQM published an update to the Guidance on the assessment of dust from demolition and construction.

This is a rewrite of previous guidance published in 2014, adopting the lessons learnt from its application. For details on what has been amended, please refer to the record of substantive amendments within the guidance document.

It is worth noting that in relation to small particulates, this guidance is focused on  $PM_{10}$  due to a current lack of empirical evidence regarding  $PM_{2.5}$  emissions from construction sites specifically.

Updates to this guidance will be made where appropriate as more evidence on  ${\rm PM}_{2.5}$  is gathered.

## Defra Air Quality Grant 23/24

The <u>air quality grant scheme</u> for 2023/2024 has been launched by Defra. Local authorities have until midday 29th September to apply for funding, which will award at least £6 million to English local authorities.

The grant has been split into application lots:

Lot 1 is for projects that will improve local air quality - especially in areas that are projected to remain in exceedance of local air quality objectives, such as for nitrogen dioxide. Defra will prioritise local authorities where an exceedance has been identified and that have one or more Air Quality Management Areas (AQMAs).

Lot 2 is for projects that will improve public awareness in local communities about the risks of air pollution, and projects for measures that deal with particulate matter.

## PM2.5 and Anti-Microbial Resistance

A global study conducted by researchers at Zhejiang University in China and published in The Lancet has shown that air pollution, specifically fine particulate matter (PM<sub>2.5</sub>) is linked to antibiotic resistance.

Globally, it is estimated that antibiotic resistance from PM<sub>2.5</sub> has caused 0.48 million premature deaths, 18.2 million years of life lost, and an annual welfare loss of \$395 billion due to premature deaths in 2018.

## Air Pollution Footprint Partnership

The Air Pollution Footprint Partnership Toolkit was launched to coincide with Clean Air Day 2023 by Ricardo and supported by Impact on Urban Health and Clean Air Fund.

It is a free reporting tool, which will support organisations in accurately reporting their air pollution emissions and allowing them to look at ways in which they can reduce their emissions and share their experiences with likeminded businesses.
